Peter Peruzzi reported that some had been planted, although some of these had been lost through drought or an over-zealous mower. Richard Price noted that the County Council could help with this. This would be put onto the next agenda.

A member of the public noted that the footway near the cottages on School Road had a parked car blocking it, it was noted that there had been a lot of work at the property and the new owner had been parking there as the vans were on the road. It was noted that it was illegal to block a footway, and that their parking was at the back of the properties. It was **agreed** that this would be investigated, and the new owner would be approached face to face to see if it could be sorted in a friendly way.

## b) County Councillor

Richard Price reported that the Environment Agency would be launching the next phase of predictions for coastal erosion, this would be circulated once received. The big issue for the County Council was devolution and local government reform. NCC had been accepted for the priority scheme, together with Suffolk, to form a Mayoral Authority for both counties. A Mayor would be elected in May 2026. The unitary authorities needed to be over 1M residents. Suffolk wanted one Unitary authority for the whole of Suffolk, and Norfolk County Council was looking at their preferred proposal, and needed to ensure that the key statutory officer positions were

well filled while making cost savings. There would be no County Council elections in May 2025.

# a) New Applications

PF/25/0292 Sun Dale, Hedgehog Walk, Bush Estate, Eccles-on-Sea: Front and rear extensions to dwelling with new duo-pitched roof over whole dwelling. Replacement side wall boundary.

It was noted that this was retrospective application. Concern was expressed that the extension was being built over a sewer access, and that there was no plan for what would be in the upstairs section. There were also concerns about the outside lighting, which had been ticked 'No' on the application form. There was no planning permission for the mobile home which had been plumbed and wired in, and this would not be able to removed once the extension was completed. Works had begun in August 2024. It was felt that this had been deliberately begun so that there was no choice but to grant retrospective permission. There were concerns about loss of privacy to the neighbouring properties, as well as a loss of light, as the proposal was imposing and out of character with the surrounding properties. It was **agreed** to object and make these comments, proposed by Gina Dunn, seconded by Helen Twining, all in favour.
