Georgina Dunn reported that the water at the church had nowhere to go, and that the culvert needed reinstating. She would keep a watching brief on this, and work did seem to have had some effect.

Peter Peruzzi reported that the ditch on The Street had been reinstated following the lorry that went into it in 2023.

The village sign had been returned and thanks were placed on record.

Peter Peruzzi reported that the roads on Bush Estate had frozen and were very slippery. It was suggested that a salt bin could be installed, possibly made from recycled materials, however the roads were not adopted so salt would need to be provided. It was suggested that this could be bought from Norfolk County Council. Councillors were asked to consider this project further.
