ii. Fishing and parking at Eccles beach.Helen Twining reported the following:

Over the summer, there have been an increased number of fishermen fishing on Eccles beach, parking down Seaside Lane, which is a Bridleway owned by the landowner, therefore blocking the entrance to the beach. Helen Twining noted on some occasions there has been litter left behind, including fishing hooks which pose a danger when left behind if they are found by pets and children. There have also been a number of people parking down Seaside Lane and launching jet skis from this area of the beach. This area of the beach is not an official launch site for jet skis due to health and safety of launching a jet ski close to other members of the public. There is an official launch site at Cart Gap. This issue has been reported to the Police, and a grid reference of Seaside Lane has been given to County Councillor Richard Price. It was noted there is a need for signs as Bush Estate is a private estate and the parking is a concern when entrances/exits are blocked. There has been a previous discussion with local residents of Bush Estate in regard to putting up No Parking signs however not all agreed, and the decision needs to be a majority. Helen Twining will email the environment agency to see if they are able to put up signs.

James Holden reported the following:

There have been a number of members of the public, walking across the sand dunes and cliffs leading towards Happisburgh. There is a clear drop in the cliff, and he raised his concerns that members of the public should be walking around, and not through the cliff as this poses a danger.

Clerk to contact Environment Agency regarding parking, jet skis and Happisburgh cliff.

- iii. Parking concerns in and around Eccles on Sea. Covered in 11. b. ii.
- iv. Bench on the Corner of The Street repairs to be done by the son on bench owner

The Parish Council has not yet received a cost of the wood, James Holden noted that the bench had been measured up and the son will look at what timber is best to use for the repairs. James Holden to speak with the son for an update.
